Information for customers – legal entities

NR COVIS S.r.l. (hereinafter “Company”), VAT number 04339690242, as processing holder of personal data provided by you, pursuant to art. 13 and 14 of Regulation (UE) 216/679, informs you that:

1) the data controller is reachable via the following channels:

- e-mail hr@covisgroup.it
- pec nrcovis@legalmail.it

2) your personal data, indicated in point 10), are processed exclusively for the following purposes:

- conclusion and proper management of sales contracts with the company you work for
- implementation of direct marketing actions

The legal bases of the processing are:

- for processing aimed at managing of sales contracts: performance of the contract or pre-contractual measures pursuant to Article 6, paragraph 1, letter b) of the GDPR
- for processing aimed at carrying out direct marketing activities: existence of a legitimate interest on the part of the data controller, pursuant to Article 6, paragraph 1, letter f) of the GDPR. The legitimate interest consists in offering products/services similar to those previously purchased by the customer.

3) your personal data may be disclosed to

- independent data controllers: natural or legal persons who manage shipping logistics
- companies, consultants, and freelancers, even associated companies, who support the Company in the sales management process
- companies, consultants, and freelancers, even associated companies, in managing the Company's IT infrastructure and providing email services.

The list of entities designated as Data Processors is available upon request, to be sent via the contact channels referred to in point 1).

4) If your organization is located in the European Economic Area, your data will not be transferred to third countries or international organizations. If your organization is located outside the EEA, the transfer will be based on the provisions of Chapter V of the GDPR for the specific case.

5) your data will be stored:

- for processing aimed at managing of sales contracts: for the entire duration of the supply relationship or until the change of contact person is communicated.
- for processing aimed at carrying out direct marketing actions: 60 months from the last purchase action.

6) at any time, you have the right to request us access to your personal data, rectification, or cancellation of your data if they have been processed in a manner that does not comply with applicable law, or limitation of its processing. To exercise your right, you must submit a request through one of the contact channels indicated in point 1).

7) in the event of a violation of your rights or incorrect processing of your personal data by our side, you have the right to contact the Data Protection Authority, which operates as the supervisory authority for the Italian territory.

8) Communication of personal data is a necessary requirement for preparing a quote and finalizing a contract. Therefore, failure to provide such data will prevent us from continuing with the business relationship.

Failure to provide such data, or objection to processing for marketing purposes, will prevent us from pursuing direct marketing activities and will have no other impact on the business relationship.

9) your personal data will not be processed based on an automated decision-making process.
