Information for access to business premises by third parties

NR COVIS S.r.l. (hereinafter “Company”), VAT number 04339690242, as processing holder of personal data provided by you, pursuant to art. 13 of Regulation (UE) 216/679, informs you that:

1) the data controller is reachable via the following channels:

- e-mail hr@covisgroup.it
- pec nrcovis@legalmail.it

2) your personal data, indicated in point 10), are processed exclusively for the following purposes:

- compliance with our regulatory obligations regarding workplace safety
- protection of company assets

The legal bases of the processing are:

- the existence of legal obligations to which we are subject, pursuant to Regulation (EU) 2016/679, Article 6, paragraph 1, letter c). Specifically, this refers to the legislation on health and safety in the workplace, which requires monitoring of individuals present at different production sites.
- the existence of a legitimate interest by the data holder, pursuant to GDPR, Article 6, paragraph 1, letter f). This legitimate interest consists in protecting against unwanted access that could lead to theft of materials or documents, or in general, information considered confidential.

3) your personal data will not be disclosed to third parties.

4) your personal data will not be transferred to third countries or international organizations.

5) your personal data will be stored for six months and then will be deleted by destroying the support on which they are recorded.

6) at any time, you have the right to request us access to your personal data, rectification, or cancellation of your data if they have been processed in a manner that does not comply with applicable law, or limitation of its processing. To exercise your right, you must submit a request through one of the contact channels indicated in point 1).

7) in the event of a violation of your rights or incorrect processing of your personal data by our side, you have the right to contact the Data Protection Authority, which operates as the supervisory authority for the Italian territory.

8) the communication of personal data is a necessary requirement for access to company premises, so failure to provide such data will result in the impossibility of access.

9) your personal data will not be processed based on an automated decision-making process.

10) the personal data taken into consideration for the processing will be the following:

- personal data
- company affiliation
- date, time of entry and exit
- reason for visit
